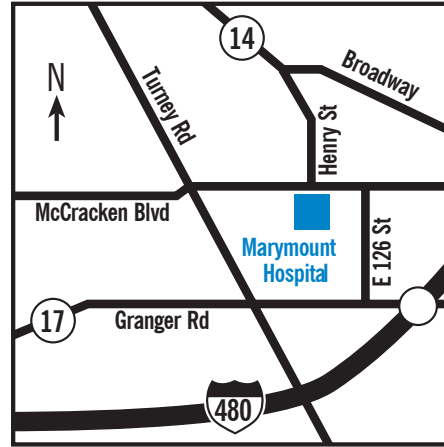




## A Tradition of Excellence

## About the School

Marymount School of Practical Nursing is located on the beautiful 26-acre Marymount campus in Garfield Heights, Ohio. The only hospital-based program in the area, we offer students the benefit of clinical experience onsite at Marymount Hospital and Villa St. Joseph, a long-term care facility located on the Marymount campus. Students gain pediatric and community experience at area Cleveland Clinic pediatric offices and local elementary schools.

While at Marymount for classes or clinical experience, students are welcome to use the hospital cafeteria and snack bar. Free parking

is available, with a complementary shuttle service to the Marymount campus.

## Admission Process

Admission to Marymount School of Practical Nursing is on a competitive basis. From the hundreds of qualified people who apply each year, 35 students are selected for admission.

Applicants must submit the following:

- Completed application form
- Official copy of high school transcripts or GED scores, transcripts from schools of nursing, vocational or trade schools and colleges attended
- Application/testing fee (20% discount for Marymount employees)
- Two references from employers, clergy or school teachers/counselors; instructions for references

are on the forms included in the application package; note that references must be mailed by the individual completing the form

## Entrance Examination and Procedures

Students applying for admission are required to take the entrance examination (scheduled twice a year). Applicants who meet or exceed the required test score will be invited to an interview with the school manager and will be asked to submit a brief writing sample during that meeting.

The Admissions Committee reviews and evaluates the applicant's total record after all forms, successful test results, transcripts and references are received. The committee notifies each applicant in writing of his or her acceptance or rejection.

All forms submitted during the application process become the property of Marymount School of Practical Nursing.

## Student Right to Information

Information on program effectiveness, including graduation rates and NCLEX-PN pass rates, is available upon request and is also provided at the interview session. Statistics are similarly available concerning the occurrence on campus of certain criminal offenses and arrests.

## Criminal Record Checks for NCLEX-PM Examination Candidates

All graduates of the program and NCLEX-PN licensure candidates will be required to submit fingerprints to the Bureau of Criminal Identification and Investigation (BCI&I) for a criminal record check. This is in accord with Sections 4723.09 and 4723.28 of the Ohio Revised Code. Additional information about this process can be found in the Marymount School of Practical Nursing Handbook that is distributed to students at orientation.
